The report will provide vital information to our field personnel in the event we are called to your property in the middle of the night in response to a disaster.

Access to Information in Emergency Situations

When disaster strikes every minute counts. Within every building the locations of cut-off valves, electric control panels, elevator controls, fire alarm panels, etc. are found in different areas of the building. In the event our crews, or your maintenance personnel, are called to respond to an emergency at your building, having the exact location of these vital building control systems available to them when they arrive will save precious time and likely additional damage to your building.

Your completed report will have a detailed location description along with photos of each:

So if crews respond day or night, or even in the dark because your building has lost power, all this information will be available to them on their smart phones, eliminating costly time searching for solutions to the problem.



Pre-Loss Services

Frequently, in the event of a loss, it is very challenging for our estimators to prove to insurance carriers the extent of the loss without the proper documentation or evidence of what the conditions were prior to the disaster.

This report will provide all the tools we need after a loss to prove your building's condition. Our inspection report will have information, and in most cases, photos of:

Along with the physical inspection of your property we would like to:

- Work with you on estimating downtime in the event of a loss so you can evaluate your business interruption insurance. This will ensure you have the money you need to pay business related expenses after a loss
- Review your insurance policy to ensure complete coverage of your property and contents. Most often we see fences, ancillary buildings, maintenance shops, cabanas, pool equipment and parking lot lighting not covered
- Work with you to make sure you understand your risk related to your deductibles
- Recommend code upgrade coverage based on what systems exist on your property and what may be required to be upgraded in the event of a loss (type of electric wiring, multiple roof layers, breaker panels, building access, bedroom window heights, energy code compliance, etc)
- Building contents and personal property
- Specialty equipment

Current Property Condition

Your completed report will have helpful information:

Use it to prove the condition of your building prior to a loss, which will help your claim go faster.

Use it to prepare a plan to address any deferred maintenance on your property.

Use it to evaluate ADA Compliance.

The report will include life expectancy estimates on the building's major operating systems.

The report will include life expectancy of your roof.

The report will include information on waterproofing of the building's exterior cladding.

The report will include information on egress lighting.

The report will include information on exit path signage.

The report will include information on wayfinding signage.

When you do capital improvements to the property, we can update our inspection report, so all the most recent information is available on our network.





Organize Vital Equipment & Inspection Information

Your completed report will have all your serial numbers and model numbers of your major operating systems, pumps, motors and panels.

Dates of when inspections are due for:
